# 4. Additional Requirements & Considerations

- Business Registration: EIN, state General Excise Tax (GET) license, and local business license (varies by county) <a href="fliprogram.com">fliprogram.com</a>.
- **Vehicle Licensing**: Proper registration, driver's license, insurance CDL may be required depending on vehicle size .
- **Fire & Zoning Permits**: Obtain local county approvals for cooking equipment, fire safety, and on-site parking.
- Liability Insurance: Often required by county or for event participation.
- Renewal & Ongoing Compliance: Annual renewal via DOH and local county; updated support kitchen agreements; periodic inspections.
